ORDER GRANTING SPECIAL DEPUTY RECEIVER'S APPLICATION FOR APPROVAL OF THIRD REPORT OF CLAIMS AND SETTING LATE CLAIMS DEADLINE

4) No late claims shall be accepted after that date because such claims would prejudice

the administration of the estate;

Application, provided that this Court shall retain jurisdiction to issue further orders

pursuant to TEX. INS. CODE Chapter 443.
