**ORDER GRANTING FIRST SUPPLEMENT TO
APPLICATION FOR APPROVAL OF FEES AND EXPENSES**

On this date, the Court heard the *First Supplemental Application for Approval of Fees and Expenses* (the “Application”) filed by CANTILO & BENNETT, L.L.P., Special Deputy Receiver of Access Insurance Company (the “SDR” and “AIC” respectively).

Having considered the Application, the Court finds as follows:

1. The *Order of Reference to Master* (“Order of Reference”) provides that motions filed pursuant to TEX. INS. CODE § 443.015 are referred to the Special Master appointed in this proceeding;
2. Notice of the Application was provided in accordance with TEX. INS. CODE §443.007 (d) and the *Order of Reference to Master*;
3. No objections to the Application were filed;
4. The Texas Property and Casualty Insurance Guaranty Association filed its acknowledgement and waiver;
5. The Special Master has issued a recommendation that the Application should be granted pursuant to Rule 171 of the Texas Rules of Civil Procedure;

6. The Court has jurisdiction over the Application and the parties affected hereunder;
and

7. The SDR's Application should be GRANTED in all respects.


IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED as follows:

1. The Application is GRANTED in all respects.
2. The terms of compensation of the individuals and contractors listed on Exhibit A to the Application are approved.
3. The anticipated expenses described in the Application are approved.
4. This Order incorporates by reference the terms of the *Order Granting Application for Approval of Fees and Expenses*.
5. This order constitutes a final judgment fully resolving all issues relating to the Application.
